Company Update -Consolidation of Capital and Lapse of Unlisted Options Appendix 3B

The Company's shareholders at the General Meeting on 28 October 2016 approved resolutions to:

- · Change the nature and scale of activities; and
- Consolidate the Company's capital

An application to change the nature and scale of activities has been made to the ASX. The Company expects a positive outcome, with reinstatement to official quotation expected to occur within the next week.

The consolidation of capital on the basis that every 20 Shares or Options be consolidated into 1 Share or Option, with fractional rounding up to the nearest whole Share or Option has been completed and new holding statements sent to shareholders.

Additionally, there has been the lapse of unlisted options in accordance with their terms of issue.

The attached Appendix 3B sets out the current issued capital of the Company.
