Unrecognised Tax Losses

The Company has ~\$45 million of Australian unused and unrealised losses available as at 31 January 2023. In the aggregate these losses equate to a potential future tax benefit of ~\$11m or ~\$0.32 per share (of which only ~\$2.3m or ~\$0.064 per share is recognised in our after tax NTA). The Company has received tax advice that these losses are available to be offset against future tax liabilities so long as NGE continues to satisfy the continuity of ownership test as set out in Divisions 165 and 166 of the Income Tax Assessment Act 1997 (Cth).



Commentary

During the month **Danakali Limited (ASX:DNK)** announced that it had executed a binding agreement to sell its 50% stake in the Colluli Potash Project to **Sichuan Road & Bridge Group (SHG:600039)**. The agreement was struck on the same terms as had been previously announced in October when the two parties signed a non-binding term sheet. We outlined our investment thesis in the November NTA Statement, which can be viewed [here](#). We added to our position following the announcement, and held ~6.1m shares as at 31 January.
